I..GENERAL COURT-MARTIAL JURISDICTION. *Effective 9 July 1956,* Army personnel of the Joint United States Military Advisory Group, Thailand, Military Assistance Advisory Groups, Vietnam and Cambodia are attached to the United States Army, Pacific for general court-martial jurisdiction. The Commanding General, United States Army, Pacific, may further attach said personnel to such general court-martial jurisdiction within his command as he may designate. Department of the Army personnel of this group will be available as members of general courts-martial convened by the Commanding General, United States Army, Pacific or of general courts-martial convened by such commander as he may designate. Direct communication is authorized with reference to court-martial matters.

II..CHICAGO QUARTERMASTER PURCHASING CENTER, ILLINOIS. *Effective 1 July 1956,* the Chicago Quartermaster Purchasing Center, Illinois, a class III installation under the jurisdiction of The Quartermaster General, is redesignated the Chicago Administration Center.
